ON THIS DATE AT APPROXIMATELY 0045, I SGT. NOCK WAS ENTERING THE INFIRMARY TO MAKE ROUNDS WHEN I WAS INFORMED BY THE DEPUTY IN CONTROL 7 THAT MEDRANO, RANDY IN INF#5 HAD JUST CALLED IN AND SAID THAT MEDRANO, JOSE IN INFIRMARY #4 HAD FALLEN. MYSELF, DEPUTY DUFFY AND DEPUTY L ROGERS WENT TO INFIRMARY #4 TO CHECK ON THE INMATE. WHEN WE ARRIVED MEDRANO WAS ON THE FLOOR IN FRONT OF THE DOOR. HE SAID THAT HIS BACK HAD BECOME WEAK AND HE HAD JUST FALLEN. I ASKED HIM IF HE HAD ANY PREVIOUS BACK INJURIES AND HE SAID NO. I CALLED THE PARAMEDIC WHO WAS IN THE INFIRMARY OFFICE WHO CAME OUT IMMEDIATELY TO CHECK MEDRANO. PARAMEDIC JOHN CHECKED HIS BACK AND NECK AND INFORMED ME THAT HE WOULD NEED TO BE TRANSPORTED TO UMC BY EMS. I OBSERVED THAT MEDRANO APPEARED TO BE IN PAIN, BUT THAT HE WAS ABLE TO MOVE BOTH LEGS AND FEET. EMS ARRIVED AT APPROXIMATELY 0050. MEDRANO, JOSE WAS ESCORTED BY DEPUTY S. LAWLER IN THE AMBULANCE. DEPUTIES MATA AND WILLIAMS FOLLOWED IN A DEPARTMENT UNIT.
