2. On June 16, 2001, I interviewed James Godwin, the owner of the Latino Paradise Club, which is located at 2228 Clovis Road, Lubbock, Texas, 79415.

3. Mr. Godwin gave me a copy of the original Monthly Report of Gross Receipts Tax, Texas Alcoholic Beverage Commission, Austin, Texas ("Monthly Sales Report") for the Latino Paradise Club for the month of August, 1996. Mr. Godwin signed and dated the copy of the Monthly Sales Report. A copy of the Monthly Sales Report provided to me by James Godwin is attached to this Affidavit at Exhibit A.

4. As reflected on the attached record, the sales for the evening of August 5, 1996 totaled \$442.50. Mr. Godwin reviewed the report and told me that the amount of sales indicated that more than three people were in the bar that night. According to Mr. Godwin, at least 15 to 30 patrons were at the bar that night to have such large sales.

FURTHER, Affiant sayeth not.

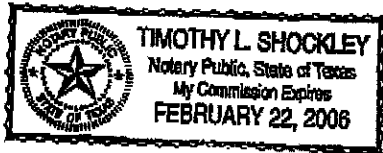
