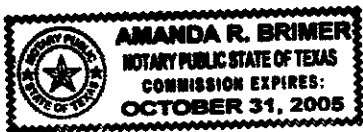
2. I am a full-time student at Texas Tech University. I live at 3715 36th Street, Lubbock, Texas 79413.
